The Covid-19 pandemic and subsequent stay at home orders have created an economic crisis the likes which hasn't been seen in decades in Michigan. Overnight, the number one issue of many small businesses went from lack of workers to how to pay the bills. HB 5766 would provide some relief, however small, to these businesses.

As businesses slowly prepares to reopen, adjust their business models, and implement proper safety protocols in order to keep their employees and customers safe, having to appeal an unfair property tax assessment by May 31 represents an undue hardship.
