## COMMITTEE MEETING MINUTES

SB 1080 (Sen. Outman)

A bill to amend 1994 PA 451, entitled "Natural resources and environmental protection act," by amending section 30705 (MCL 324.30705), as amended by 2002 PA 215.

SB 757	(Sen. Ruth Johnson)	A bill to amend 1954 PA 116, entitled "Michigan election law," by amending sections 765, 765a, and 765b (MCL 168.765, 168.765a, and 168.765b), sections 765 and 765a as amended by 2020 PA 95, section 765b as added by 2018 PA 127, and by adding sections 14b and 24k.

4. Amend page 22, line 8, after "the" by striking out "**day**" and inserting "**Saturday, Sunday, and Monday**".
5. Amend page 22, line 16, after "**the**" by striking out "**day**" and inserting "**Saturday, Sunday, and Monday**".
6. Amend page 23, line 4, after the second "**the**" by striking out "**day**" and inserting "**Saturday, Sunday, and Monday**".
7. Amend page 23, line 9, after the second "**the**" by striking out "**day**" and inserting "**Saturday, Sunday, and Monday**".
8. Amend page 24, line 7, after "**the**" by striking out "**day**" and inserting "**Saturday, Sunday, and Monday**".
9. Amend page 24, line 22, after the first "**the**" by striking out "**day**" and inserting "**Saturday, Sunday, and Monday**".
10. Amend page 32, line 10, after "**the**" by striking out "**day**" and inserting "**Saturday**".
