## COMMITTEE MEETING MINUTES

Tuesday, October 31, 2023

9:00 AM

Room 519, House Office Building

The House Committee on Criminal Justice was called to order by Chair Hope.

The Chair requested attendance be called:

Representative Andrews moved to adopt the meeting minutes from October 24, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5075 before the committee:

HB 5075 (Rep. Bezotte)

A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending sections 520c, 520d, 520e, and 520g (MCL 750.520c, 750.520d, 750.520e, and 750.520g), sections 520c, 520d, and 520e as amended by 2012 PA 372.

- HB 4482 (Rep. Brixie) A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 5851b (MCL 600.5851b), as added by 2018 PA 183.
- HB 4483 (Rep. Steckloff) A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 5805 (MCL 600.5805), as amended by 2018 PA 183.
- HB 4484 (Rep. Arbit) A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending sections 6431 and 6452 (MCL 600.6431 and 600.6452), section 6431 as amended by 2020 PA 42 and section 6452 as amended by 2020 PA 44.
- HB 4485 (Rep. Miller) A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 24 of chapter VII (MCL 767.24), as amended by 2018 PA 182.
- HB 4486 (Rep. Whitsett) A bill to amend 1964 PA 170, entitled "An act to make uniform the liability of municipal corporations, political subdivisions, and the state, its agencies and departments, officers, employees, and volunteers thereof, and members of certain boards, councils, and task forces when engaged in the exercise or discharge of a governmental function, for injuries to property and persons; to define and limit this liability; to define and limit the liability of the state when engaged in a proprietary function; to authorize the purchase of liability insurance to protect against loss arising out of this liability; to provide for defending certain claims made against public officers, employees, and volunteers and for paying damages sought or awarded against them; to provide for the legal defense of public officers, employees, and volunteers; to provide for reimbursement of public officers and employees for certain legal expenses; and to repeal acts and parts of acts," by amending section 7 (MCL 691.1407), as amended by 2013 PA 173, and by adding section 7d.
- HB 4487 (Rep. Scott) A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 6431 (MCL 600.6431), as amended by 2020 PA 42.

1. Amend page 2, line 18, after "or" by striking out "**section**" and inserting "or sections 5805".
2. Amend page 2, line 19, after "who" by inserting a comma and "while a minor,".
3. Amend page 2, line 20, after "conduct" by inserting "after December 31, 1996 but".

4. Amend page 2, line 20, after "before" by inserting "2 years before".
5. Amend page 2 line 21, after "the" by striking out "**2023**".
6. Amend page 2, line 21, after "that" by striking out "**amended**" and inserting "added".
7. Amend page 2, line 22, after "section" by striking out "**is revived and the individual**".
8. Amend page 2, line 24, by striking out "**before 2 years**" and inserting "within 90 days".
9. Amend page 2, line 24, after the second "the" by striking out "**2023**".
10. Amend page 2, line 25, after "that" by striking out "**amended**" and inserting "added".
11. Amend page 2, line 25, after "section" by striking out the period and inserting "if the person alleged to have committed the criminal sexual conduct was convicted of criminal sexual conduct against any person under section 520b of the Michigan penal code, 1931 PA 328, MCL 750.520b, and the defendant admitted either of the following:

(a) That the defendant was in a position of authority over the victim as the victim's physician and used that authority to coerce the victim to submit.

(b) That the defendant engaged in purported medical treatment or examination of the victim in a manner that is, or for purposes that are, medically recognized as unethical or unacceptable."
