The House Committee on Criminal Justice was called to order by Chair Hope.

HB 5400 (Rep. Arbit) A bill to amend 1931 PA 328, entitled "The

Michigan penal code," by amending section 147b (MCL 750.147b), as added by 1988 PA 371.

HB 5401 (Rep. Grant) A bill to amend 1927 PA 175, entitled "The code

of criminal procedure," by amending section 16g of chapter XVII (MCL 777.16g), as amended by

2023 PA 278.

Representative Arbit and Representative Grant testified together in support of HB 5400 and HB 5401. Questions and discussion followed.
