My name is Melissa Nita and I am a resident of Royal Oak, Michigan. I live at 506 West Lincoln Ave. We have been out of power since Wednesday, February 23rd around 3 p.m. Since then, we have gotten three updates on power restoration, however, it has never come back on. Currently, the DTE Outage Map states "New Restoration Date in Progress". There are only 19 houses on our block that are out of power, so many of us feel that we have completely been overlooked.

I am confused as to why this is not considered a state of emergency after six days without power? We live in Michigan, where winters without heat is not an option. Our fridge full of groceries has gone bad and we have been only offered a \$25 credit. My family, which includes my husband, my two year old, my dog, and myself who is 8 months pregnant. Having no power or food and being displaced for almost a week seems completely unacceptable.

I have contacted DTE several times and have gotten nowhere. We are beyond frustrated and completely at a loss of what to do next. I am asking for help - help contacting others, help restoring our power, help making this an emergency situation, anything at this point.
