The Chair laid HB 5382, HB 5383, HB 5384, HB 5385, HB 5386, and HB 5387 before the committee:

HB 5382	(Pscholka)	Individual income tax; collections; earmark to community district education trust fund; provide for.
HB 5383	(Price)	Education; financing; community district education trust fund; create.
HB 5384	(Garcia)	Education; school districts; education district; create.
HB 5385	(Poleski)	State financing and management; authorities; Michigan financial review commission; expand to include education districts.
HB 5386	(Jacobsen)	Retirement; public school employees; participation in Tier 2 for employees first hired in a community district after a certain date; require.
HB 5387	(Garcia)	Education; employees; certain subjects of collective bargaining for public school employers organized as community districts; limit.

Brian Whiston, the State Superintendent, testified on the bills. Questions and discussion

followed.
