Department of Civil Rights

- Mission is to secure the full and equal enjoyment of civil rights in Michigan by eliminating discrimination, assuring equal protection, and effectively managing and embracing diversity
- Civil Rights Commission was established in 1963 when guarantees against discrimination were added to the Michigan Constitution
- Department of Civil Rights was established in 1965 to serve as the administrative arm charged with implementing policies of the Commission
- Department has investigative and enforcement authority

Civil Rights Responsibilities

- Enforce the state's civil rights laws
- Provide educational programs that promote voluntary compliance with civil rights laws; activities include networking, partnership, presentations, crisis intervention, training, and technical assistance
- Investigate and resolve discrimination complaints in the areas of employment, public accommodations and service, education, housing, and law enforcement
- Provide information and services to businesses on diversity initiatives, equal employment law, procurement opportunities and feasibility studies, and joint venture/strategic alliance matchmaking


Civil Rights Budget

Civil Rights spending increases primarily due to inflation; decreases due to budget reductions.




Civil Rights Share of State GF/GP

Civil Rights Share of General Government GF/GP


FY 2009-10 GF/GP = \$625,194,200

FY 2009-10 Gross Revenue = \$13,763,700




STATE SPENDING

Civil Rights Spending

- Complaint Investigation and Enforcement: investigates discrimination complaints and enforces civil rights laws
- Outreach and Education: collaborates with governmental units, community-based organizations, law enforcement, advocacy groups, educational institutions, and the private sector
- Mediation: alternative dispute resolution
- Community Relations Division: enhances communication, provides new options in service delivery, facilitates access to outreach and education, develops and maintains partnerships and initiatives
- Contract Compliance Unit: establishes standards and procedures for ensuring non-discrimination in the provision of programs, services, and funding
- Office of Legal Affairs: provides legal guidance and strategy on issues and cases, litigates cases, writes amicus briefs on pending court cases, reviews pending legislation, designs and implements grants for fair housing program
- Michigan Women's Commission: works to improve the quality of life for women in the areas of employment, education, health, home, and community



FY 2009 Complaint Issue Contacts Recorded by Area of Discrimination




