On behalf of the Michigan Fire Inspectors Society and myself as a Paid-on-Call Firefighter with the Plainwell Department of Public Safety I am asking Rep. Rendon to support Rep. Yaroch's House Bill 4063 - Cancer Presumption.

This Bill would allow volunteer, paid-on-call and part time fire fighters to be eligible under the First Responders Presumed Coverage Fund if they develop one of the 10 specified types of cancers.

- The First Responders Presumed Coverage Fund is NOT funded by state general funds and is not an expansion of the Workers Compensation Act. The addition of all fire fighters would have NO FISCAL IMPACT on the state.
- There is secured funding through restricted revenues coming from the recently passed online gaming legislation.
- This will expand the list of cancers to include breast and ovarian.

This disease hits close to home as my wife is a former career and paid-on-call firefighter and cancer survivor.

As for my self I have been a firefighter for 53 years, both as a career fire fighter and paid-on-call. One of my biggest fears in life is the impact of cancer.

Thank you and again I encourage support for HB 4063.

But I will continue to do this job, my calling, until either it kills me, or I physically cannot do it anymore.

Many of my brothers and sisters in this service are not as lucky as I have been. My injury will not kill me. Will it cause me pain? Yes. But I will live. Many of my brothers and sisters have died, are dying, and will die from cancer caused by exposures in the line of duty, and who knows, maybe at some point in my life it will hit me too. That is a risk I personally, and all of the people in this service take, and we will continue to take it, with no second thoughts. We love what we do, and we love being able to help our communities during the worst times of their lives.

It is time we start taking care of those who put their lives on the line every single day, without hesitation, knowing that this job may very well end our lives. We will gladly give our lives, if it means someone else is to live. Anytime something happens, we get praise, which is not why any of us who are in this field for the right reasons do it. We are not heroes... we are ordinary men and women, who were chosen and lucky enough to be able to do what we do. But it is time that we get taken care of as well. I am tired of seeing my brothers and sisters suffering and dying due to cancer that we got from helping people of our communities. It is time for government, whether it be on the federal, or state level, to be there for us in our time of need.
