According to David E. Martin, PhD, a linguistics specialist who has been tracking patent applications and approvals since 1998, there are over 4000 patents relating to the SARS coronavirus. His analysis of these patents shows that Sars-Cov-2 is not a novel (natural) coronavirus at all, but rather a manmade virus that has been in the works for over two decades. In particular, there are over 120 patented pieces of evidence that relate to 3 specific features of the virus-a cleavage site for SARS-CoV, the Spike protein, and the ACE2 binding site. Much of the research regarding the virus has been funded by non-other than NIAID under the direction of Dr Anthony Fauci. Since he has been there since 1984, he has given out over \$50 billion in funding for varieties of research. As early as 1999, patents were sought regarding the SARS corona virus. Prior to 1999, coronavirus patents were all in the veterinary sciences. In fact, the first coronavirus vaccine to use the spike protein was patented by Pfeizer in Jan, 2000. You cannot patent something that is natural, it would have to be manipulated or changed to get a patent for it. In 1999, Dr Fauci funded research at University of NC Chapel Hill to create an "infectious replication defective coronavirus" specifically targeted for human lung epithelium. The coronavirus lab at University of NC is headed by Ralph Baric-who has collaborated for years with Dr ZhingLi who heads the Wuhan lab. The patent for this "replication defective virus" was filed April 19, 2002

### Virus

 2003- SARS hits Asia. That same year, CDC applies for patent on Coronavirus. From 2003 to 2018, everything and anything to do with coronavirus and all the money involved with it was now controlled by Fauci, Baric, and the CDC.

- 2011 NIH becomes involved in Gain of Function.
  - a. Gain of Function- process to get a virus to jump species from its usual host to humans. In this case ferrets were used as intermediaries, as they carry the same ACE receptors on their cells that humans have and to which the virus attaches on to enter cells. Many scientists, epidemiologists, ID doctors warned against the Gain of Function research- fearing it could cause pandemic- intentional or accidental

#### b. In 2011, the MERS-Middle East Respiratory Syndrome hits

- 2014 Government stops Gain of Function research until more guidelines are established. NIH then goes outside the country- to Wuhan China to continue the coronavirus research, including Gain of Function. \$7.4 million- taxpayer money, given to China by NIH and NIAID. The money was not given directly, but funneled to companies or organizations which had dealings with China and the Wuhan lab. Eco Health Alliance- run by Peter Dazak, was such an organization. It was involved in Gain of Function research with the Wuhan lab.
- 2017- the ban is lifted
- In April 2021 during a press meeting, a reporter from Newsweek magazine asked Dr. Fauci about whether he was at all concerned that the Gain of Function might result in a pandemic- his answer was "The benefits outweigh the risks". The question is benefits to

whom? Clearly the benefit is to the drug companies who create these vaccines. Pfeizer made \$3.5 billion in the first quarter of 2021 and projects to make \$26 billion by the end of the year. Moderna made \$1.75 in the first quarter of 2021. They anticipate that these vaccines will be needed for years to come. You can expect more variants and more booster shots for years to come.

 Moderna had actually partnered with NIAID to manufacture the vaccine. Ever wonder why Dr Fauci promotes the vaccines so much, especially Moderna. According to him, nothing will save mankind but vaccines. Any other alternatives, such as hydroxychloroquine and Ivermectin have been downplayed, ignored, restricted in their use, and removed from social media discussions.

## **Vaccine**

- Not a true vaccine, but gene therapy.
  - Standard vaccine uses a weakened virus or part of virus to stimulate the immune system.
  - o This gene therapy uses a synthetic mRNA that, once inside a cell, induces the cell to make the Spike protein. The immune system would recognize the spike protein and when the real virus infects a vaccinated person, it will be attacked and eradicated. mRNA is normally quickly degraded unless somehow protected. In this case, it is wrapped by a metallic nanoprotein that has been bathed in PEG- polyethylene glycol- the same ingredient in antifreeze. This nanoparticle not only enters cells, but it crosses the BBB and enters the brain- with unknown long term effects. Nanoparticles will

stay in the body for years, potentially decades. These so called vaccines have not been tested long enough to observe their long term effects. In fact, they are to be observed until 2023 before they are fully approved by FDA. However, the FDA will likely approve them shortly, as Dr Fauci has said they would.

• This gene therapy was never tested in any human trials until July of 2020. The 43,000 volunteers tested using the Pfeizer vaccine were the first guinea pigs. All other prior studies were on animals. In those studies, the majority of the animals died.

# Reported side effects after vaccine

Broken into 4 different types of categories

Cardiac-Myocarditis- inflammation of heart muscle

Pericarditis- inflammation of the sac around the heart

**Heart Attacks** 

**Neurologic**- paralyses, Guillain-Barre' Syndrome, Covid brain fog, Bell's Palsy- Chronic headaches, inflammation of the eyes, chronic fatigue, strokes

**Hematologic**- blood clots. A woman in Minnesota received the 2<sup>nd</sup> dose of the Pfeizer vaccine because it was mandated by her boss. She developed clots in her peripheries and developed gangrene. She ultimately lost both legs and hands

Yet the CDC's web site they list the following common side effects for the vaccine

On the arm-pain, redness, swelling

Throughout the rest of the body- Tiredness, headache, muscle pain, chills, fever, nausea

Compare that to what the FDA says about **Ivermectin**- one of the drugs being used world-wide to treat covid- "you should not use Ivermectin to treat or prevent Covid-19". They include words and phrases like "serious harm, hospitalized, dangerous, seizures, highly toxic, coma, death"- Anything to denigrate the drug. Yet the FDA approved it as a "safe and effective anti-parasitic drug"

# Long term effects- unknown

Parkinson's disease, ALS- Lou Gehrig's disease, Alzheimer's dementia, Autism, autoimmune diseases, cardiac issues, chronic fatigue syndrome and God knows what else.

Here is something to consider. The chemical Roundup-the herbicide, was created in 1974. It wasn't until 2018 before it was associated with causing Non Hodgkins Lymphoma. How long will it take to see the long term effects of these so called vaccines? You will be hard pressed to say the vaccines were responsible- good luck trying to prove it.

## ADE-antibody dependent enhancement

More and more vaccinated patients are being admitted with covid infection- being labeled as breakthrough cases. It's believed these are due to ADE. The antibodies produced by the vaccine are different, they are weakened or sub-optimal. When the virus does infect the body, it is not eradicated but actually picked up by these antibodies and introduced inside the cells, where it reproduces and multiplies. Patients actually get sicker than if they had no vaccine. That is what is happening with this Delta variant.

All over the world we are seeing more vaccinated patients being admitted for Covid than unvaccinated patients. In the US, the CDC and media would have us believe it's the other way around. That it's essentially just the unvaccinated people and the media labels them as the "super spreaders".

In fact natural immunity provides a far broader protection because it is not narrowed to just the spike protein. In one study that is referenced by Dr Gerry Quinn, a post-doctoral researcher in microbiology and immunology, people who were infected with the first wave of Sars-Cov-2, their plasma had 4 antibodies that were extremely potent against 23 variants of SARS.

In Gibraltar, nearly every adult in the tiny country has been vaccinated, yet it has the 3<sup>rd</sup> highest per capita rate of infection.

Cyprus had the most Covid cases per capita on earth, before the most recent wave occured, they had already vaccinated the majority of their adult population.

According to the Indian Council of Medical Research the country had achieved near herd immunity and burned out the virus with only 3% of the population having been vaccinated. Strict masking failed to stop the spread there. Their death rate is roughly 1/6 that of the US and UK and less than ½ that of Israel. India has essentially only the Delta variant and they are describing it as cold-like symptoms. Yet here we are told that the Delta variant is deadlier than the first wave. All scare tactics to get the people to vaccinate.

According to CDC web site, "vaccine monitoring has historically shown side effects generally happen within 6 weeks of receiving a vaccine dose." We are seeing side effects lasting months and possibly years

CDC picks and chooses how to interpret data. A 2 mo old baby in Mich dies of gastroschisis, where the intestines are outside the body. However, because the baby had Covid, cause of death is attributed to Covid. In reality the complications associated with the baby's underlying medical condition caused his/her death, not the virus. I had a patient in his 90's who died of old age. Because he had Covid a month prior, I couldn't indicate old age as the cause of death. It fell under Covid.

Yet serious side effects or death that may occur several days after the so called vaccine, those are not attributed to the vaccine. In Australia a teenager gets 1st dose of Astra-zeneca vaccine and becomes paralyzed. Doctors refuse to attribute it to the vaccine, they blamed it on mental stress, bad home situation, etc. A 52 yo man, previously healthy, died of a heart attack 1 week after

getting the Pfeizer vaccine- doctors refused to associate his death with the vaccine. A 69 yo woman gets cognitive and physical decline after the first dose of the vaccine. She had family history of factor 5 Leiden deficiency. She passed away 5 weeks later. Another woman goes into a coma 3 weeks after getting Astrazenca vaccine. None of these are reported in MSM. When people joined a Facebook group- total members 60,000, to talk about the side effects they had experienced, their Facebook site was removed without explanation, silencing anyone who spoke against the vaccines.

One particular case of a 24 yo female in Mich developed facial numbness and tingling, right sided weakness, chronic headaches after 2<sup>nd</sup> dose of Pfeizer vaccine. Doctors refused to attribute it to the vaccine, even though all tests are negative. 20 yo male college student at University of Ohio dies 1 day after getting the J&J vaccine-coroner would not attribute death to vaccine- he attributed to acute heart failure- labeled it as a natural cause of death. 13 yo boy in Mich died in his sleep 3 days after getting 2<sup>nd</sup> dose of Pfeizer vaccine. 20 yo WSU pre-med student dies days after getting 2<sup>nd</sup> dose of vaccine- brand not identified. The incidents go on and on.

# CDC VAERS- vaccine adverse effects reporting system

There are thousands more cases like these, but you rarely hear of them. It is estimated that the system reports only between 1-10 % of

what is really happening. The latest CDC website report has 6207 reported deaths after getting the vaccine. Prior to that revision, the CDC had actually reported 12,313 deaths from Dec 14 to July 19, 2021 after the vaccine was given.

## Some facts about Ivermectin

- originated from a microorganism from Japanese soil in the 1970's
- it is used to treat river blindness and other diseases in Africa and other places where parasites are common
- it fights 21 viruses including Sars-Cov-2. A single dose reduced the viral load in cells by 99.8% in 24 hrs and 99.98% in 48 hrs-according to the journal "Antiviral Research"
- it is safe for pregnant women, children and infants
- It can be used to treat as well as prevent Covid. One 2020 article in Biochemical and Biophysical Research Communications in which the drug was given to family members of confirmed Covid patients, less than 8% became infected, vs 58.4 % of those untreated.
- Among 200 healthcare workers and others at high risk of exposure, only 2 % of those given Ivermectin developed Covid-19, while the control group had 10%.
- -According to American Journal of Therapeutics, over 4 billion dosed of Ivermectin have been administered since 1998

and only 28 cases of serious neurological adverse events have occurred.

If the FDA had any credibility, they would have approved Ivermectin for emergency use to treat Covid-19. But the FDA, like the CDC, NIH, and NIAID no longer service the people- they service themselves and big Pharma. Ivermectin will not enrich the drug companies. To buy it at the pharmacy, it can cost between \$30-\$70 for 20 (3mg) tablets. The drug Remdesivir that is used to treat hospitalized patient-usually for 6 doses, will cost \$520/ vial- thus \$3120 with insurance. If no insurance it will cost \$390/vial- thus \$2340. Which do you think the FDA, CDC, NIH and Fauci have pushed for?

There is an unholy alliance between the government, the so called medical experts- CDC, NIH,FDA, Dr Fauci and his NIAID and others, MSM, Social media, and private businesses such as hospitals, to push the vaccines on the entire population and the world and silence anyone who dares speak out against the so called vaccines.
