Hello,

I am asking that you and your committee please (please, please) support HB 4471 (The Workplace Exemption Bill). My husband is an employee at the public schools and has received notice that all employees will be required to be vaccinated or undergo *daily* rapid antigen testing. We oppose both options.

The actual data, according to the state of Michigan, is that there have been a total of *15* deaths in children aged 0 to 19 years, over a period of 18 months! Without question most of these (if not all of them) were very likely in children with underlying conditions. Joy,
I am a military veteran. I do not support mandated vaccines pertaining to covid19 in any fashion due to the lack of peer reviewed studies and trials.

Please support bill HB4471. If you do not, I demand a response with the 'science' behind your decision. While you may not have researched this as much as I have from the beginning, there is absolutely zero reason to infringe on the human and civil rights of your citizens anymore.

What you are participating in, by mandating vaccines of any sort right now, is endangering lives. The working middle class is nearly destroyed and this is one of the main objectives. I hope you trust a military intelligence analyst over whatever you watch for news.

Reasons to not mandated vaccines:

1. People have died. The CDC has lied multiple times about the numbers. Any other study in history was shut down after only a handful of cases.
2. The 'Delta variant' is more transmissible, but less deadly than the original covid strain. The Case Fatality rate of the delta variant is about 0.2% without the approximate efficacy rate of a vaccine of 91%. Simply put, you have a 0.2% chance of getting seriously sick and dying without the vaccine and a greater chance to get struck by lightning in your lifetime than dying from having the vaccine. Airborne viruses typically mutate down. Humans are the host and method of transmission. Think about this, why would a virus want to become more lethal and kill the host? It would kill itself off. Please support HB 4471 (The Workplace Exemption Bill)

This bill aims to protect employees from vaccination mandates by their employer for 3 vaccines; influenza, Tdap, and COVID-19 vaccination. It prevents an employer from discharging, failing or refusing to hire, or otherwise discriminate against an individual with respect to their vaccination status.

This bill also prevents an employer from requiring an individual who declines these vaccines from being forced to wear a face mask or a distinguishing mark, for example a sticker on their badge, that indicates whether they have received a vaccine, or not.

The bill also requires the employer to notify employees of their right to decline the vaccines.

This bill also allows an employee to take civil action against their employer for violating this act and obtain costs, reasonable attorney fees, and treble damages if they prevail.

Madam,

Simply put.

If "vaccines" work, then no one else need be concerned if someone else isn't "vaccinated"

If "vaccines" don't work then no one need be concerned if someone else hasn't been "vaccinated".

Some may still argue about overwhelmed hospitals/ICU's, but let's look at the numbers. When there was no vaccine available, some hospitals in densely populated areas were at full or greater capacity in their ICU's, and mostly due to "covid"...so it is said, but I digress. Some much smaller hospitals in much less densely-populated areas felt the same strain. But that's where it stopped.

Even though PRESIDENT Trump had made available our largest medical vessels for use as floating covid wards, they went all but unused, even in the most heavily populated areas, where they were stationed. The facility created at PRESIDENT Trump's order in New York went entirely unused. The vast majority of urgently created respirators went unused as well. Again, this happens with zero percent of the population "vaccinated".

Today we see told that roughly 65% or more Americans have taken the "vaccine". Given current numbers, that means that 220,000,000 or our 330,000,000 people have been "vaccinated", leaving only 33% or, 110,000,000 people unvaccinated. If we factor in all those who had contracted covid prior to the "vaccine" being available, and who now carry the antibodies naturally created by there immune systems, as it should be, making the "vaccine" unnecessary for them, then based on the total number of people who actually contacted covid before the vaccine was available, we can reduce the 110,000,000 down to about 100,000,000, with the usual 3-4% margin for error.

If the "vaccines" work, and those having had it supposedly likely to suffer minimal effects from reinfection, this leaves only about 30% of our population who could even POSSIBLY....MAYBE...need the type of hospitalization which was seen in 2020. The question which then remains is this...

If those who became deathly ill from the virus from 100% of the population did NOT actually overwhelm our ability to treat those so affected, then less than 1/3 of the population who remain unvaccinated have LITTLE chance of producing even similar strain on hospitals/ICU's and, thanks to PRESIDENT Trump's actions, we know of and have available "overflow" facilities (the ships, etc) in place, should that 1/3 of the population experience what would have to be a 66% greater amount of persons needing ICU-type hospitalization than did the original 100%.

One can easily see the the likelihood of such occurring is all but a mathematical impossibility and, as such, precludes any such argument as having any basis in science or reason.

It comes down to a person having the right to be "secure in their persons", as stated in the Fourth Amendment to The Constitution of the United States. Not that any further support for opposition to such mandates would be needed, but if there is, I would cite Nuremberg's declaration that it is a violation of human rights to force a person to "accept" something being injected into their person against their will.

Dear Representatives Griffin, Martin, Howell, Farrington, Eisen, Markkanen, Sabo, Hope, and O'Neal,

I agree that the three vaccines stated in the bill should not be mandated by private employers. I hope you will pass it out of committee and get this on the books to protect the freedom and the opportunity to work for all Michigan residents no matter vaccine status.

I really do think we are at a crossroads as far as retaining or abdicating personal freedom. No matter what the threat, I know from history that society at large is still better off and ultimately "safer" when the individuals who make up that group can choose the best course of action for themselves and their families. Otherwise, they can quickly find themselves enslaved by the very government, via private companies and federal agencies in this case, in the name of safety, that was supposed to protect their liberties.

I'm not sure how else to describe it, but enslavement, if we and our children can no longer say yes or no to a shot or booster shots.
