COMMITTEE MEETING MINUTES

Thursday, October 19, 2023

The House Committee on Labor was called to order by Chair Haadsma.

The Chair requested attendance be called:

Representative Kunse moved to adopt the meeting minutes from October 12, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4932 and HB 4962 before the committee:

HB 4932 (Rep. Skaggs)

A bill to amend 1978 PA 90, entitled "Youth employment standards act," by amending sections 2, 3, 20, 21, and 22 (MCL 409.102, 409.103, 409.120, 409.121, and 409.122), section 2 as amended by 1996 PA 438, section 3 as amended by 1997 PA 132, and section 22 as amended by 1980 PA 436.

HB 4962 (Rep. Scott)

A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 14b of chapter XVII (MCL 777.14b), as added by 2002 PA 29.

A substitute (H-1) was adopted for HB 4932 at the October 12th, 2023 meeting.

Representative Kunse introduced and explained his package of amendments to HB 4932 (H-1). Questions and discussion followed.

Representative Kunse offered the following amendment to HB 4932 (H-1):

1. Amend page 5, line 4, by striking out all of subdivision (c).

Representative Kunse moved to adopt the amendment to HB 4932 (H-1). The motion did not prevail 3-7-0:

Representative Kunse moved to adopt the amendment to HB 4932 (H-1). The motion did not prevail 3-7-0:

1. Amend page 6, line 26, after "**not**" by striking out the balance of the subdivision and inserting "**more than \$68,801.00 or, if the violation is repeated or willful, not more than \$137,602.00.**".

2. Amend page 7, line 1, after "**not**" by striking out the balance of the subdivision and inserting "**more than \$68,801.00 or, if the violation is repeated or willful, not more than \$137,602.00.**".

3. Amend page 7, line 5, after "**not**" by striking out the balance of the subdivision and inserting "**more than \$68,801.00 or, if the violation is repeated or willful, not more than \$137,602.00.**".

Representative Kunse moved to adopt the amendments to HB 4932 (H-1). The motion did not prevail 3-7-0:

The Chair laid HB 5026 before the committee:

HB 5026 (Rep. Martus)

A bill to provide for the transition of transition-impacted industries into new industries; to create the community and worker economic transition office in the department of labor and economic opportunity; to create certain advisory committees; and to provide for the powers and duties of certain state governmental officers and entities.

Representative Martus and Senator Singh testified in support of HB 5026. Questions and discussion followed.

Ryan Sebolt, representing the American Federation of Labor and Congress of Industrial Organizations, testified in support of HB 5026.

Jean Duchemin, representing the United Auto Workers Local 1753, testified in support of HB 5026.

Jason Peek, representing the United Auto Workers Local 602, testified in support of HB 5026. Questions and discussion followed.

Robert Joerg, representing the Laborers' International Union of North America, testified in support of HB 5026. Questions and discussion followed.

The Chair laid SB 169 before the committee:

SB 169 (Sen. Cherry)

A bill to amend 1947 PA 336, entitled "An act to prohibit strikes by certain public employees; to provide review from disciplinary action with respect thereto; to provide for the mediation of grievances and the holding of elections; to declare and protect the rights and privileges of public employees; to require certain provisions in collective bargaining agreements; to prescribe means of enforcement and penalties for the violation of the provisions of this act; and to make appropriations," (MCL 423.201 to 423.217) by adding section 11a.

Senator Cherry, and Jonavan Luckey, representing the Service Employees International Union 517M, testified in support of SB 169. Questions and discussion followed.

Steve Rzeppa, representing the American Federation of State, County and Municipal Employees, testified in support of SB 169. Questions and discussion followed.

Jennifer Smith, representing the Michigan Association of School Boards, testified in opposition to SB 169.
