## COMMITTEE MEETING MINUTES

The House Committee on Regulatory Reform was called to order by Chair Tyrone Carter.

The Chair laid SB 247 before the committee:

SB 247 (Sen. McCann)

A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998," by amending section 531 (MCL 436.1531), as amended by 2014 PA 135.

Senator McCann, and Marlon Lynch, representing the Michigan State University Department of Public Safety, testified in support of SB 247. Questions and discussion followed.
