The House Appropriations Subcommittee on General Government was called to order by Chair Brabec.

Representative Lightner moved to adopt the meeting minutes from March 19, 2024. There being no objection, the motion prevailed by unanimous consent.

Rep. O'Neal moved to place the House Substitute for HB 5516 (H-1) before the House Subcommittee for discussion.
