

Program History

- Established as the "Kammer Recreational Land Trust Fund" Act via 1976 PA 204 (land acquisition)
- Proposal B passed in Nov. 1984 & the Legislature enacted the Michigan Natural Resources Trust Fund Act via 1985 PA 101 (development added)
- Proposal P passed in Nov. 1994 (corpus changed to \$400M)
- Proposal 2 passed in Aug. 2002 (corpus changed to \$500M)
- 2011, MNRTF corpus reached \$500M
- Since 1976, over \$1.1 billion awarded for nearly 2,500 projects in every Michigan county

- Acquisition breakdown:
 - Local agencies, 22 grants totaling \$12,006,000
 - State, 8 grants totaling \$6,644,600
- Development breakdown:
 - Local agencies, 30 grants totaling \$6,853,400
 - State, 4 grants totaling \$540,000
- 64 grants totaling \$26,044,000 leveraging \$15,871,000 in match for a total investment of \$41,915,000
