The House Standing Committee on Financial Services was called to order by Chair Farrington.

The Chair laid HB 5084 before the committee:

HB 5084 (Rep. Farrington) A bill to amend 2009 PA 75, entitled "Mortgage loan originator licensing act," by amending sections 3 and 5 (MCL 493.133 and 493.135), section 3 as amended by 2012 PA 150 and section 5 as amended by 2014 PA 421, and by adding sections 5a and 5b.
