Re: Increasing organ transplants in Michigan via the HOPE Act

Dear Chair Kahle and members of the Health Policy Committee,

I am writing to voice my strong support for changes to the Michigan Public Health Code that will increase the number of lives saved in our state by allowing our medical centers to transplant organs in accordance with the federal HIV Organ Policy Equity Act, or HOPE Act. This federal legislation allows organs from HIV-positive donors to be transplanted into recipients who are also HIV-positive.

In the State of Michigan, transplant centers have been reluctant to consider organs from deceased donors who are HIV-positive and offering them to HIV-positive recipients under the federal HOPE Act. This is so because of the Michigan Public Health Code that has not been amended to be in line with current practice and the federal HOPE Act that was signed into law November 21, 2013. In the context of organ transplantation, these patients are missing opportunities at lifesaving transplants. Furthermore, organ demand for lifesaving transplants continues to outstrip the demand, which has been worse in the Covid era.

In Michigan, all transplant centers work collaboratively and with Gift of Life Michigan, the state's only organ and tissue donation program. Gift of Life Michigan already recovers organs from HIV-positive donors under the HOPE Act. But because of outdated language in the Public Health Code, those organs are sent out of state instead of saving patient lives here, in Michigan. The legislation before you would remove that restriction on transplanting these organs into Michigan patients, bring the state into line with federal law, increase efficiency and give hope to the more than 2,500 residents waiting for this life-saving gift. The Gift of Life Michigan Governing Board and Advisory Board – including representatives of the state's nine organ transplant programs – endorse this effort to boost the number of organs for transplant for their patients. In addition, the Henry Ford Transplant Institute, the most comprehensive transplant center in the State, strongly supports amending the Public Health Code in Michigan as noted above.
