## COMMITTEE MEETING MINUTES

The House Committee on Regulatory Reform was called to order by Chair Hauck.

Representative Bellino moved to adopt the meeting minutes from June 8, 2021. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4660 before the committee:

HB 4660 (Rep. Bezotte)

A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending sections 654 and 698a (MCL 257.654 and 257.698a).

(H-1) to HB 4660 was adopted at the June 8, 2021 committee meeting.
