The House Committee on Transportation was called to order by Chair O'Malley.

The Chair laid HB 6123 before the committee:

HB 6123 (Rep. Damoose)

A bill to amend 1945 PA 327, entitled "Aeronautics code of the state of Michigan," by amending section 80f (MCL 259.80f), as added by 2001 PA 225.

Representative Damoose testified in support of HB 6123.

SB 640 (Sen. Zorn) A bill to amend 1949 PA 300, entitled "Michigan vehicle code," by amending section 722 (MCL 257.722), as amended by 2018 PA 274.

SB 745 (Sen. Zorn) A bill to amend 1978 PA 639, entitled "Hertel-Law-T. Stopczynski port authority act," by amending sections 2, 4, 8, 9, 14, and 22 (MCL 120.102, 120.104, 120.108, 120.109, 120.114, and 120.122), section 14 as amended by 2002 PA 412.
