## COMMITTEE MEETING MINUTES

(Rep. Hauck) A bill to amend 1975 PA 238, entitled "Child protection law," by amending section 3 (MCL 722.623), as amended by 2016 PA 35.

HB 4305 (Rep. Vaupel) A bill to amend 1982 PA 294, entitled "Friend of the court act," by amending sections 2, 2a, 17, and 19 (MCL 552.502, 552.502a, 552.517, and 552.519), section 2 as amended by 2015 PA 253 and sections 2a, 17, and 19 as amended by 2009 PA 233.

HB 4321	(Rep. Afendoulis)	A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16d of chapter XVII (MCL 777.16d), as amended by 2016 PA 88.
