Representative Scott moved to adopt the meeting minutes from September 14, 2023. There being no objection, the motion prevailed by unanimous consent.

The Chair laid SB 356, SB 357 and SB 358 before the committee:

| SB 358 | (Sen. Klinefelt) | A bill to amend 1956 PA 218, entitled "The insurance code of 1956," (MCL 500.100 to 500.8302) by adding section 3406z. |

1. Amend page 2, line 12, after "is" by striking out the balance of the subsection and inserting "the de minimis variation as described in 45 CFR 156.140."
2. Amend page 3, line 21, after "2213b," by striking out "or to".
3. Amend page 3, line 22, after "147.140" by inserting a comma and "**or a catastrophic plan as described in 45 CFR 156.155**".

Representative Rogers moved to adopt the amendments to SB 358. The motion prevailed 16-0-0:
