The House Committee on Regulatory Reform was called to order by Chair Tyrone Carter.

SB 544 (Sen. Klinefelt) A bill to amend 1980 PA 299, entitled "Occupational code," (MCL 339.101 to 339.2677) by adding article 18A.

SB 545 (Sen. Klinefelt) A bill to amend 1979 PA 152, entitled "State license fee act," (MCL 338.2201 to 338.2277) by adding section 43a.
