The House Appropriations Subcommittee on Licensing and Regulatory Affairs, Insurance and Financial Services was called to order by Chair Skaggs.

The Chair requested attendance be called:

Representative Schuette moved to excuse Representative DeBoer from the meeting. There being no objection the motion prevailed by unanimous consent.

Representative Morse moved to adopt the meeting minutes from March 12, 2024. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 5513 before the committee:

HB 5513 (Rep. Skaggs)

A bill to make appropriations for the department of insurance and financial services for the fiscal year ending September 30, 2025; and to provide for the expenditure of the appropriations.

Representative Brixie moved to adopt substitute (H-2) to HB 5513. The motion prevailed 7-0-0:

2. Amend page 6, line 12, after "fees" by striking out "6,213,400" and inserting "4,863,400" and adjusting the subtotals, totals, and section 201 accordingly.
