| SB 0283 | (Sen. Lucido) A bill to amend 1976 PA 451, entitled "The revised school code," by amending sections 5 and 1178 (MCL 380.5 and 380.1178), as amended by 2016 PA 385; and to repeal acts and parts of acts. |
