## **COMMITTEE MEETING MINUTES**

HB 4378 (Rep. Garza) A bill to amend 1893 PA 206, entitled "The

general property tax act," by amending sections 27 and 34d (MCL 211.27 and 211.34d), section 27 as amended by 2019 PA 116 and section 34d as

amended by 2019 PA 117.

HB 4379 (Rep. Garza) A bill to amend 1995 PA 24, entitled "Michigan

economic growth authority act," by amending section 3 (MCL 207.803), as amended by 2010 PA

272.
