AGENDA:

HB 4129

Elections: offenses; intimidating an election inspector or preventing an election inspector from performing his or her duties; prohibit.

PIME POSITION: OPPOSE

Michigan absolutely cannot start making people felons if someone else says that their feelings were hurt. This is exactly what HB4129 would allow. Intimidation is already illegal. Courts have ruled on that. But this bill goes too far. It says "Intimidate" means to commit harassing conduct that would cause a reasonable individual to feel terrorized, frightened, threatened, harassed, or molested."

We are **frightened by this bill!** Does that make the bill sponsor a felon? If someone says something at a voting location that offends or frightens an election official, are they now subject to felony charges, incarceration, and fines if an election official claims they "feel" intimidated? **The state cannot start prosecuting people based upon people's feelings**. Besides violating the Ist amendment of our Constitution, this sort of legislation can open doors for groups of people to be attacked for their beliefs (poll watchers and challengers come to mind).

Michigan already has laws preventing intimidation and assault, and legal methods in place to handle difficult individuals at polling locations or anywhere else for that matter. HB4129 needs to be struck down entirely. If not, we have to question if this

bill's actual intent is to discourage honest, hardworking citizens from exercising their duty to oversee fair elections.
