## COMMITTEE MEETING MINUTES

Tuesday, November 10, 2020      8:30 AM      Room 352, House Appropriations, State Capitol Building

The House Committee on Tax Policy was called to order by Chair Afendoulis.

At 8:32 AM, the Chair laid the committee at ease.

At 8:35 AM, the Chair called the committee back to order.

The Chair requested attendance be called:

Representative Lower moved to adopt the meeting minutes from September 22, 2020. There being no objection, the motion prevailed by unanimous consent.

The Chair laid SB 970 before the committee:

SB 970      (Sen. Runestad)

A bill to amend 1993 PA 327, entitled "Tobacco products tax act," by amending sections 2 and 11 (MCL 205.422 and 205.431), section 2 as amended by 2012 PA 188 and section 11 as amended by 2016 PA 86.

Senator Runestad testified in support of SB 970.

The Chair laid HB 6284, HB 6285, HB 6286, HB 6196 and HB 6197 before the committee:

HB 6284      (Rep. Huizenga)

A bill to amend 1893 PA 206, entitled "The general property tax act," (MCL 211.1 to 211.155) by adding section 9p.

HB 6285 (Rep. Warren)	A bill to amend 1933 PA 167, entitled "General sales tax act," (MCL 205.51 to 205.78) by adding section 4hh.
HB 6286 (Rep. Filler)	A bill to amend 1937 PA 94, entitled "Use tax act," (MCL 205.91 to 205.111) by adding section 4hh.
HB 6196 (Rep. Sheppard)	A bill to amend 1933 PA 167, entitled "General sales tax act," (MCL 205.51 to 205.78) by adding section 4gg.
HB 6197 (Rep. Tate)	A bill to amend 1937 PA 94, entitled "Use tax act," (MCL 205.91 to 205.111) by adding section 4gg.
