Dear House Members Ways/Means and Committee Clerk:

Please enter this email into public testimony.

Please **OPPOSE HB 4035!** This bill will negatively impact public safety and remove local control. The cost to public safety would be too great should this reckless bill pass.

Michigan's predominant public policy for over a century has embodied the principle that **local governments must have broad authority to shape matters of local concern.** The public policy of local control has been prescribed and enshrined in the Michigan constitution. Those matters of local concern should be shaped by those closest to the people - **local government**.

HB 4035 STRIPS local control from almost 40 Michigan communities that have worked to enact and enforce their safety ordinances. These communities should have the right to decide what works best for them! HB 4035 has been written and promoted by out of state special interest animal rights groups that have no business writing policies for Michigan that would negatively impact public safety.

Pit Bulls are the number one canine killer of people, pets, and livestock every year. The trend in animal shelters and rescue groups to promote fighting breed dogs as 'safe family pets' is resulting in an epidemic of serious injury and death.

*Please note that Michigan BANNED wolf-dog mixes in 2000 after a suspected wolf dog killed one child in 1996. To date, pit bulls have killed over 600 Americans, including Michiganders. (FatalPitBullAttacks.com)

Last year, 2019, Michigan had three FATAL pit bull attacks.

November 2019- Brandy O'Dell, age 41, Bay City, fatally mauled by her 2 pet pit bulls

October 2019- Benjamin Cobb, age 4, fatally mauled by fostered pit bull his mother brought home. Benjamin was killed the same day.

August 2019- Emma Hernandez, age 9, fatally mauled by neighbor's 3 pit bulls.

<u>December 2019- Oakland County Animal Control Supervisor brutally mauled by pit bull. The dog had to be shot and killed to stop the attack.</u>


