While our career personnel have been covered for the past several years, HB 4063 would provide for volunteer, paid-on-call and part time fire fighters to also be eligible under the First Responders Presumed Coverage Fund if they develop one of the 10 specified types of cancers. With cancer being the leading cause of firefighter deaths, it is imperative that our volunteer, paid-on-call and part time firefighters also be covered. After all, the dangers faced by firefighters are the same, regardless of their pay status.

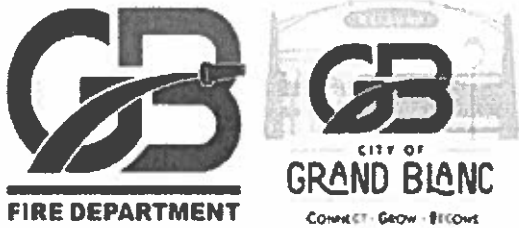
