The House Standing Committee on Ways and Means was called to order by Chairman Iden.

The Chair laid HB 4112 before the committee:

HB 4112 (Rep. Vaupel) A bill to amend 1998 PA 58, entitled "Michigan liquor control code of 1998,"(MCL 436.1101 to 436.2303) by adding section 905a.

Representative Leutheuser offered the following amendment to HB 4112:

1. Amend page 2, line 4, by striking out "**develop and furnish the sign.**" and inserting "**include the message required under this subsection in the sign furnished by the commission under section 701.**".

Representative Leutheuser moved to adopt the amendment to HB 4112. The motion prevailed 11-0-0:

HB 4067	(Rep. Calley)	A bill to amend 1972 PA 230, entitled "Stille-DeRossett-Hale single state construction code act,"(MCL 125.1501 to 125.1531) by adding section 4h.
