The House Committee on Judiciary was called to order by Chair Filler.

HB 5862 (Rep. Borton)

A bill to provide limited immunity from civil liability for personal injury or property damage to owners and operators of campgrounds and their employees.

Gary Becker and John Lindley, representing the Michigan Association of Recreational Vehicles and Campgrounds, testified in support of HB 5862. Questions and discussion followed.

Eugenie "Genie" Eardley, representing the Michigan Association for Justice, testified in opposition to HB 5862. Questions and discussion followed.
