To whom it may concern -

I support HB 4667 for a number of reasons, but here are just a few:

1. Vaccine passports will allow for segregation between vaccinated and unvaccinated members of society. We all know segregation ended with the Civil Rights Act of 1964. We don't need to go back to a segregated society that we broke free from decades ago.
2. Vaccine passports will allow for discrimination of unvaccinated members of society. Again, thanks to the civil rights act of 1964, under federal law it is illegal to discriminate on the basis of race, color, religion, sex or national origin. However, unvaccinated members of society are not a protected class under federal law and will be subjected to discrimination if vaccine passports are allowed therefore violating basic human and civil rights.
3. Vaccine passports are a violation of a right to medical privacy. thanks to HIPPA laws, my medical history and my medical decisions are private between myself and my physician. I can authorize others to have access to my medical information if I'd like, but my medical information is not available for public access and public information and neither should my vaccine status be.

As a devout Catholic, I will not take a drug that has been formed using unborn children, in this case the covid-19 vaccine.
