The lineman stated I was lucky to be alive. I thought I had simply been chopping through another root but later learned I'd placed a number of other gashes in the cable's outer jacket with metal-handled shovels and spades minutes earlier. I am a retired Electrical Engineer and don't like knowing I only survived by luck this time. Because I was not physically injured, no attorney would bring suit against MissDig for negligence. Although the service to the home was repaired and re-routed, I'll admit I am still spooked about going back down that hole to finish the job with the old service line still down there. Anyway, this all gets back to quality of oversight and contractor management. Although I followed all the rules, the failure of Miss Dig to do their job properly could have easily caused my death or disfigurement that day last summer. I made several attempts to alert MissDig and get their management to follow up on my complaint to no avail.

Representative Scott,

I'm writing this morning to insist that you use your power as the chair of the Energy, Communications and Technology Committee to hold a public hearing and demand that DTE executives answer to their customers. While I do not live in your District, I am writing due to your role as chair on this important committee.

My family and I live on the eastside of Detroit and over the last 6 years we have experienced not only poor service, but also personal loss of property, and the impact of trauma on our family, friends, and community. More than any inconvenience or nuisance, repetitive long-term outages have deeply impacted many aspects of our lives.

Where we live, we almost always retain power through the worst of the storm but lose power the next day. My assumption is that they turn us off to turn other areas on, but I'm not a line worker. It does create a loss of trust and a great sense of disparity. All efforts should be made to retain power for those who have it. My neighborhood is 90% Black and extremely economically disadvantaged. If this is the result of a decision being made, I wonder if this also happens in more affluent areas of DTE's service?

We've lost lighting, ceiling fans, small appliances and (new) power strips in surges during outages or more specifically when the power comes back on. I've now learned to turn everything off at the box during an outage.

Refrigerator and freezer food loss is also substantial when you have 3 kids. After losing refrigerators full of food multiple times, we decided to save up for a generator. We're blessed to be able to do so as many of our neighbors cannot. Last week, once again I was running cords over fences in the middle of an ice storm to try to get some power to our neighbor's homes.

One of our elder neighbors lost heat last week, but she was too concerned to leave her house over fear of a fire sparking up while away. I not only understand but share her fear. A few years ago, after a long-term outage, the power came back on and caused multiple simultaneous house fires in the neighborhood. It was chaos with neighbors running hoses, bringing ladders, and holding down a house fire on the block until the overwhelmed Detroit Fire Department arrived on the scene. The house was so damaged that the family haven't returned to the street.

I think what angers me more than anything else is the indirect impact of these outages on my kids, my elder neighbor, and the rest of my community. My kids don't sleep well, sometimes even when there is a minimal storm, for fear of outages and fire. Our children and our elders have enough challenges with the state of our neighborhood, city and world. That this level of trauma and abuse comes from a service that we pay for seems inherently unjust.

Again, I'm writing to insist you do everything in your power as the committee chair to hold a public hearing and demand that DTE executives answer to community.

I am unable to attend the hearing on Wednesday morning, but hope that this statement can be read when appropriate.

My name is Jane ONeil, and I live in Bloomfield Township, Michigan. On the evening of February 22, I was on a zoom meeting when I lost power. I used my electric car to charge my phone and iPad so that I could stay in communication with the outside world even while I had no heat, and no power. As I came back into my family room from the garage, I heard an enormous noise, as two branches came through the roof of my family room. Alone in my dark cold house, I spent the evening listening to more branches come down, calling the insurance company, the tree company, and a contractor. Lucky for me the next day I was invited to stay with a friend. My friend Drieka was not so lucky, she stayed in a hotel with her dog for two nights. When my power returned, she and her dog came to my house for two nights. Finally, her power came back on after being off for four days. Meanwhile I learned I had contracted Covid. I am grateful that I had power while I was sick. By Friday, I was feeling well again, and sitting in my kitchen Friday evening, when the power went out again. I spent another night, listening to the storm alone in my cold, dark house. The next morning, another friend, Jan, invited me to stay with her. She had lost power during the first outage for five days, but was lucky enough to be able to hook into her neighbor's generator, which enabled her to stay at home, working for the duration. By now, I was feeling homeless, driving around with my belongings in my car, depending on the kindness of my friends. I never received any communication from DTE with an estimate for how long it would take to turn the power back on. Finally, I got a message saying they had completed work in my neighborhood, and asking me if power was back on. Happily, it was.



I am writing to express my concern regarding DTE Energy's failure to deliver on its responsibility to provide reliable, affordable, and clean energy to its customers. The recent power outages resulting from ice storms across the state left over 600,000 DTE customers without power, and many residents without electricity for consecutive days.

I was without power for 6 days, had to check into a hotel for 4 days, and lost a lot of freezer and refrigerator food. And THEN...3 days after I got home I lost power again for 24 hours. When I finally got power back, I had to do 16 loads of laundry.

In the face of widespread power outages affecting DTE customers across the utility's service area, DTE is proposing record-breaking rate increases that threaten to raise energy bills for customers at a time when reliable service cannot be guaranteed. Many of these same customers are already struggling to make ends meet as the cost of living crisis continues to grow.
