The House Committee on Military, Veterans and Homeland Security was called to order by Chair Conlin.

The Chair laid HB 5276, HB 5277, HB 5279, HB 5280 and HB 5720 before the committee:

HB 5276 (Rep. Conlin)	A bill to create the office of mental health and suicide prevention in the Michigan veterans affairs agency and provide for its powers and duties; and to provide for the powers and duties of certain state governmental officers and entities.
HB 5277 (Rep. Morse)	A bill to amend 1967 PA 150, entitled "Michigan military act," (MCL 32.501 to 32.851) by adding section 322.
HB 5279 (Rep. Brabec)	A bill to amend 1967 PA 150, entitled "Michigan military act," (MCL 32.501 to 32.851) by adding section 323.
HB 5280 (Rep. Bruck)	A bill to amend 1967 PA 150, entitled "Michigan military act," (MCL 32.501 to 32.851) by adding section 321.

HB 5720 (Rep. Bezotte)

A bill to require the department of military and veterans affairs to make certain mental health and wellness resources available to members of the Michigan National Guard and other military servicemembers.
