The House Committee on Communications and Technology was called to order by Chair Hoitenga.

The Chair requested attendance be called:

Representative Coleman moved to adopt the minutes from the September 9th, 2020. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4288 before the committee:

HB 4288 (Rep. Hoitenga)

A bill to prescribe the powers and duties of certain state governmental officers and entities; to create a statewide broadband service grant program; and to establish a process for the application and awarding of grant funds.

Representative Wozniak moved to adopt substitute (H-2) to HB 4288. The motion prevailed 5-0-0:
