The House Standing Committee on Education was called to order by Chair Hornberger.

The Chair laid HB 4368 and HB 4369 before the committee:

HB 4368 (Rep. Hornberger) A bill to amend 1979 PA 94, entitled"

The state school aid act of 1979,"by repealing section 160

(MCL 388.1760).

HB 4369 (Rep. Johnson) A bill to amend 1976 PA 451, entitled" The

revised school code," by amending section 1284a (MCL 380.1284a), as added by 2007 PA 101; and to repeal acts and

parts of acts.

Representative Paquette moved to adopt substitute (H-1) to HB 4369. The motion prevailed 13-0-0:
