Representative Sowerby offered the following amendments to HB 4282 (H-1):

- 1. Amend page 4, line 23, after "(2)" by inserting "In addition to the requirements under subsection (1), beginning with pupils entering grade 3 in 2006, KINDERGARTEN IN 2020, the board of a school district or board of directors of a public school academy shall not award a high school diploma to a pupil unless the pupil has successfully completed during grades K to 12 at least 2 credits that are 1 CREDIT THAT IS grade-appropriate in a language other than English, AS DESCRIBED IN SECTION 1278F, or course work or other-ANOTHER learning experiences that are EXPERIENCE THAT IS substantially equivalent to 2 credits 1 CREDIT in a language other than English, based on guidelines developed by the department."
  - 2. Amend page 5, line 14, after "to" by striking out "6." and inserting "8.".
