Representative Vaupel moved to adopt the meeting minutes from June 11, 2019. There being no objection, the motion prevailed by unanimous consent.

The Chair laid HB 4184 before the committee:

HB 4184

(Rep. Farrington) A bill to amend 1966 PA 331, entitled "Community college act of 1966,"by amending section 166 (MCL 389.166), as added by 2008 PA 359.

HB 4675 (Rep. Afendoulis) A bill to amend 1976 PA 451,

entitled "The revised school code," by amending sections 1311d and 1311g (MCL 380.1311d and 380.1311g), section

1311d as added by 1999 PA 23 and section 1311g as

amended by 2018 PA 42.
