Warren) | A bill to amend 2010 PA 270, entitled "Property assessed clean energy act," by amending the title and sections 1, 3, 5, 7, 9, 11, 13, 15, 17, and 19 (MCL 460.931, 460.933, 460.935, 460.937, 460.939, 460.941, 460.943, 460.945, 460.947, and 460.949), sections 3 and 9 as amended by 2017 PA 242, and by designating section 1 as part 1 and sections 3 to 19 as part 2. |
