SB 783	(Sen. Runestad)	A bill to amend 1915 PA 31, entitled "Youth tobacco act," (MCL 722.641 to 722.645) by adding section 1a.
SB 784	(Sen. Theis)	A bill to amend 1915 PA 31, entitled "Youth tobacco act," by amending section 1 (MCL 722.641), as amended by 2019 PA 18.
SB 785	(Sen. Zorn)	A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending section 42b (MCL 750.42b), as added by 1992 PA 273.
SB 786	(Sen. Wojno)	A bill to amend 1971 PA 79, entitled "Age of majority act of 1971," by amending section 3 (MCL 722.53).
