COMMITTEE MEETING MINUTES

The Chair laid HB 4069 and HB 4465 before the committee:

HB 4069	 (Rep. Kahle) A bill to amend 1893 PA 206, entitled"The general property tax act,"by amending sections 27 and 34d (MCL 211.27 and 211.34d), section 27 as amended by 2013 PA 162 and section 34d as amended by 2014 PA 164.
HB 4465	(Rep. Rabhi) A bill to amend 1893 PA 206, entitled"The general property tax act,"by amending section 9i (MCL 211.9i), as added by 2002 PA 549.

Representative Lower moved to adopt substitute (H-1) to HB 4069. The motion prevailed 15-0-0:
