
Department of Environment, Great Lakes, and Energy Bottle Deposit Revenue Programmatic Impacts For Fiscal Year 2020

Overview


The revenue provided by the unclaimed bottle deposits supports statewide contaminated site cleanups efforts to protect public health and the environment. In addition, the funds facilitate brownfield redevelopment and provide grant opportunities to local units of government for waste reduction efforts. HB 5423 would significantly reduce EGLE's funding for existing efforts. Approximately 75% of the funding supports operational costs while 25% supports direct contaminated site cleanup costs.

Operations

The current proposal in HB 5423 would reduce \$20 million to the cleanup and redevelopment fund which is the primary funding source for 130 staff responsible for the oversight of cleanup of contaminated sites. Staff are located throughout the state as follows:

In addition, there are 30 staff who oversee and administer the 65 federal superfund sites. The staff costs are primarily supported by the contaminated site cleanup funding which is also applied towards the federally required match dollars.
