The Chair laid HB 5756 and HB 5757 before the committee:

HB 5756 (Rep. Mueller)

A bill to amend 1972 PA 222, entitled "An act to provide for an official personal identification card; to provide for its form, issuance and use; to regulate the use and disclosure of information obtained from the card; to prescribe the powers and duties of the secretary of state; to prescribe fees; to prescribe certain penalties for violations; and to provide an appropriation for certain purposes," (MCL 28.291 to 28.300) by adding section 2a.

HB 5757 (Rep. Mueller)

A bill to amend 2008 PA 23, entitled "Enhanced driver license and enhanced official state personal identification card act," (MCL 28.301 to 28.308) by adding section 5a.

Representative Lilly moved to adopt substitute (H-3) to HB 5756. The motion prevailed 11-0-

- 1. Amend page 5, line 14, after "**Before**" by striking out "**January**" and inserting "**April**".
- 2. Amend page 5, line 18, after "after" by striking out "January" and inserting "April".
- 3. Amend page 5, line 20, after "to" by striking out "a medical condition" and inserting "military duty, medical condition,".

4. Amend page 5, line 22, after "**January 1**," by striking out "**2021**," and inserting "**2022**,".

Representative Warren spoke to her amendments.

A bill to amend 1943 PA 240, entitled "State employees' retirement act," by amending section 68c (MCL 38.68c), as amended by 2020 PA 18.

as amended by 2013 PA 146, and by adding section 32c.

A bill to amend 1978 PA 368, entitled "Public health code," by amending section 21717 (MCL 333.21717), as amended by 2014 PA 66, and by adding section 5145.

 - 2. Amend page 7, following line 27, by inserting:
- "(2) Through December 31, 2020, a nursing home may admit or retain for care an individual who has tested positive for coronavirus if any of the following apply:
- (a) The department of health and human services has not implemented a process for the creation of care and recovery centers within nursing homes under section 5145(1)(d).
- (b) The nursing home has applied for the approval of a designated area within the nursing home under section 5145(1)(e) and the department of health and human services has not approved the application." and renumbering the remaining subsection.

Representative Lilly spoke to his amendments.

Representative Lilly moved to adopt the amendments to SB 1094(H-2). The motion prevailed 11-0-0:
