HB 4729	(Rep. Cherry)	A bill to amend 1875 PA 54, entitled "An act to facilitate the inspection and reproduction of the records and files in the offices of the registers of deeds," by amending section 1 (MCL 565.551), as amended by 2007 PA 58.
HB 4730	(Rep. Calley)	A bill to amend 1895 PA 161, entitled "An act to require county treasurers to furnish transcripts and abstracts of records, and fixing the fees to be paid therefor," by amending section 1 (MCL 48.101), as amended by 2015 PA 39.
HB 4731	(Rep. Manoogian)	A bill to amend 1996 PA 462, entitled "Enhanced access to public records act," by amending section 3 (MCL 15.443), as amended by 1998 PA 550.
HB 4732	(Rep. Marino)	A bill to amend 1961 PA 236, entitled "Revised judicature act of 1961," by amending section 2567 (MCL 600.2567), as amended by 2016 PA 224.
