COMMITTEE MEETING MINUTES

Tuesday, February 23, 2021 12:00 PM Room 326, House Office Building

The House Committee on Elections and Ethics was called to order by the Chair Bollin.

HB 4134	(Rep. Bollin)	A bill to amend 1954 PA 116, entitled "Michigan election law," by amending sections 658, 659, and 661 (MCL 168.658, 168.659, and 168.661), sections 658 and 661 as amended by 2012 PA 270 and section 659 as amended by 2014 PA 94, and by adding section 759e.

2. Amend page 2, line 18, after the first "**birth**" by striking out "**and proof of date of birth**".

3. Amend page 2, line 21, after "**card**" by striking out "**and provide proof of date of birth**".

4. Amend page 3, line 1, by striking out all of subsection **(3)** and renumbering the remaining subsections.

5. Amend page 3, line 7, after "**subsection**" by striking out "(5)," and inserting "(4),".

6. Amend page 3, line 8, after "card" by striking out the comma and "**and provides proof of his or her date of birth,**".
