COMMITTEE MEETING MINUTES

The House Committee on Elections and Ethics was called to order by Chair Bollin.

HB 4837	(Rep. Lightner)	A bill to amend 1954 PA 116, entitled "Michigan election law," by amending sections 5090 and 509r (MCL 168.5090 and 168.509r), section 5090 as amended by 2018 PA 126 and section 509r as amended by 2018 PA 125.
HB 4840	(Rep. Borton)	A bill to amend 1954 PA 116, entitled "Michigan election law," by amending sections 811 and 847 (MCL 168.811 and 168.847), section 811 as amended by 2018 PA 603 and section 847 as amended by 2012 PA 271.
HB 4305	(Rep. Steven Johnson)	A bill to amend 1976 PA 388, entitled "Michigan campaign finance act," by amending section 26 (MCL 169.226), as amended by 2019 PA 93.
HB 4425	(Rep. Green)	A bill to amend 1954 PA 116, entitled "Michigan election law," (MCL 168.1 to 168.992) by adding section 685a.

HB 4788 (Rep. Markkanen)

A bill to amend 1895 PA 3, entitled "The general law village act," (MCL 61.1 to 74.25) by adding section 5b to chapter II.
