election law," by amending sections 523, 813, and

829 (MCL 168.523, 168.813, and 168.829), section 523 as amended by 2018 PA 129 and sections 813 and 829 as amended by 2018 PA 603.

SB 304 (Sen. VanderWall) A bill to amend 1954 PA 116, entitled "Michigan

election law," by amending sections 523a and 813 (MCL 168.523a and 168.813), as amended by

2018 PA 603.
