COMMITTEE MEETING MINUTES

Thursday, June 16, 2022 8:30 AM Room 519, House Office Building

The House Committee on Health Policy was called to order by Chair Kahle.

The Chair requested attendance be called:

Representatives Meerman, Allor and Neeley joined the committee remotely.

Representative Filler moved to adopt the meeting minutes from June 9, 2022. There being no objection, the motion prevailed by unanimous consent.

HB 6139	(Rep. Brann)	A bill to amend 1980 PA 350, entitled "The nonprofit health care corporation reform act," (MCL 550.1101 to 550.1704) by adding section 414c.

SB 190	(Sen. VanderWall)	A bill to amend 1974 PA 258, entitled "Mental health code," by amending section 137 (MCL 330.1137), as amended by 2015 PA 59, and by adding section 137b.
