The House Committee on Military, Veterans and Homeland Security was called to order by Chair LaFave.

At 12:00 PM, the Chair laid the committee at ease.

At 12:07 PM, the Chair called the committee back to order.

HB 5883	(Rep. Berman)	A bill to amend 1931 PA 328, entitled "The Michigan penal code," by amending sections 227 and 231a (MCL 750.227 and 750.231a), section 227 as amended by 1986 PA 8 and section 231a as amended by 2012 PA 427.
HB 5884	(Rep. Berman)	A bill to amend 1927 PA 175, entitled "The code of criminal procedure," by amending section 16m of chapter XVII (MCL 777.16m), as amended by 2018 PA 637.
