## COMMITTEE MEETING MINUTES

Tuesday, June 11, 2024

The House Committee on Economic Development and Small Business was called to order by Chair Hoskins.

The Chair laid SB 481 before the committee:

SB 481 (Sen. Klinefelt)

A bill to amend 2006 PA 317, entitled "An act to create certain entities in the Michigan strategic fund; to impose certain duties and responsibilities on those entities and on certain state employees and public employees; and to repeal acts and parts of acts," by amending section 2 (MCL 125.1972), as amended by 2010 PA 337.

Renee Wilson, Legislative Director for Senator Klinefelt, Bree Anderson, representing MEDC, and Tanya Markos-Vanno, representing Apex Accelerators, testified in support of SB 481.

At 9:12 AM, the Chair laid the committee at ease.

The Chair laid HB 5557 before the committee:

HB 5557 (Rep. Grant)

A bill to amend 2008 PA 33, entitled "Michigan planning enabling act," by amending sections 7,

15, and 33 (MCL 125.3807, 125.3815, and 125.3833), section 7 as amended by 2010 PA 134, section 15 as amended by 2010 PA 105, and section 33 as amended by 2010 PA 306.

Representative Grant moved to report out HB 5557 with recommendation. The motion prevailed 12-0-1:

SB 559 (Sen. McMorrow)

A bill to amend 1984 PA 270, entitled "Michigan strategic fund act," by amending sections 9, 88s, and 88t (MCL 125.2009, 125.2088s, and 125.2088t), section 9 as amended and section 88s as added by 2021 PA 136, and section 88t as added by 2021 PA 134, and by adding section 88u.

SB 562 (Sen. Cavanagh)

A bill to amend 2000 PA 489, entitled "Michigan trust fund act," by amending sections 2 and 4 (MCL 12.252 and 12.254), section 2 as amended by 2023 PA 174 and section 4 as added by 2021 PA 137.

HB 5768 (Rep. Hoskins)

A bill to amend 1967 PA 281, entitled "Income tax act of 1967," (MCL 206.1 to 206.847) by adding section 695a; and to repeal acts and parts of acts.

HB 5769 (Rep. Morgan)

A bill to create a transformational projects authority; to prescribe the powers, duties, and jurisdictions of the transformational projects authority; to provide for the awarding of certain transportation-related grants; to prescribe the powers and duties of certain state governmental officers and entities; and to provide for the promulgation of rules.

HB 5770 (Rep. McFall)

A bill to amend 2000 PA 489, entitled "Michigan trust fund act," (MCL 12.251 to 12.262) by adding section 4a.

Steve Vagnozzi, Government Affairs Coordinator for the Michigan Association of Railroad

Passengers, testified in support of HBs 5768, 5769, 5770, and SBs 559 and 562.

Representative Martin offered the following amendment to HB 5768:

1. Amend page 2, line 5, after "**125.1458a.**" by inserting "**It is the intent of the legislature that the money deposited under this subdivision must not be used to provide any services, grants, or other program assistance to a recipient who is not a United States citizen unless that recipient is a qualified alien as that term is defined under 8 USC 1641.**".

Representative Martin moved to adopt the amendment to HB 5768. The motion did not prevail 6-7-0:

1. Amend page 3, line 27, after "senate." by inserting "Of the members appointed by the governor, 1 must be appointed from a list of 3 or more nominees submitted by the speaker of the house of representatives, 1 must be appointed from a list of 3 or more nominees submitted by the minority leader of the house of representatives, 1 must be appointed from list of 3 or more nominees submitted by the senate majority leader, and 1 must be appointed from a list of 3 or more nominees submitted by the senate minority leader. Each list described in this subsection must include not less than 1 individual with expertise in public transportation.".

Representative Roth moved to adopt the amendment to HB 5769 (H-1). The motion prevailed 13-0-0:

1. Amend page 9, line 26, after "that" by striking out the balance of the line and inserting "connects to public transportation, is".
2. Amend page 9, line 27, after "or" by inserting "has a".

Representative Roth moved to adopt the amendments to HB 5769 (H-1). The motion prevailed 13-0-0:

1. Amend page 7, line 28, after "2025" by inserting "The authority shall not issue bonds, notes, or any other evidence of indebtedness." and renumbering of the other sections.

Representative VanWoerkom moved to withdraw the amendment. There being no objection, the motion prevailed by unanimous consent.

Representative Neeley moved to report out HB 5769 with recommendation, as amended, as substituted (H-2). The motion prevailed 8-3-2:
