#### Chairman Koleszar and Members of the Education Committee:

On behalf of NAF, I am writing in strong support of H.B. 5649 that would require a computer science course to be offered in public high schools throughout Michigan, thereby providing additional opportunities for students to prepare themselves for the workforce skills that are in demand.

NAF is a national education non-profit that brings schools and businesses together to transform the high school experience and to better align education and workforce opportunities through career focused academies – including academies focused in areas such as engineering, IT and finance.
